Are you ready for an ambitious August amble? Starting at the Oak Creek parking lot in the MacDonald Forest, we will hike up Directissima (named by Julia B) to the top of Dimple Hill. Most routes are about 3.5 miles, this one is only 1.5 miles because it's steep. We'll take an easier

route back that will be 3.5 miles long, depending on the weather and the interest of the group. This hike is intended to challenge your stamina and to have fun. Hiking poles are recommended but not required. Dogs are welcome to join us. There is some poison oak along the way so plan to decontaminate yourself if you are susceptible like Maya is. SAVE THE DATE for our Annual Willamette Valley Broadband Gathering in Brownsville Sunday, October 6th at noon



Wilderness Monitoring UPDATE 2024

Unfortunately, the lighting storms in mid-July caused fires in the Diamond Peak Wilderness and near the Middle Santiam Wilderness, so the Forest Service has closed all of Diamond Peak Wilderness and Middle Santiam Wilderness. This means that we cannot do any of our wilderness monitoring at this point.

There's always hope that the fires get put out and we can do some work in the wilderness areas this season, but it's unlikely that they will reopen this season.

We're working on getting the grant money to roll over to next year, but it may not happen. In that case, we would need to apply for a new grant. Is anyone interested in leading this effort?
